**What is the Freedom Scholars Program?**

Tri-County Freedom Scholars are outstanding high school students who qualify for additional scholarship assistance through their significant academic achievement, as well as financial need. Students apply at the end of 8th grade. Tri-County's goal is to offer special support to these exceptional students, funding 40-50 Freedom Scholars per year.

**Expectations, Benefits and Results of being a Freedom Scholar**

Freedom Scholars benefit from having the bulk of their tuition paid, with their families paying the remainder. They benefit academically from special mentoring, tutoring, and assistance with college testing and essay preparation during junior and senior years. Freedom Scholars exhibit high achievement, meeting the expectation to maintain a 3.0 or better GPA. The results are impressive: Tri-County Scholars have been awarded full tuition scholarships at top colleges in New Jersey and throughout the country including: Rutgers, Seton Hall, Georgetown, Villanova, Cornell, Colgate, Notre Dame, UCLA, and University of Pennsylvania.
